PERFORMANCE OF NDMA

(QUARTERLY REPORT - 3rd QUARTER 2018)

1. **Overview.** Third Quarter of the Year 2018 was mainly revolved around preparations and monitoring of Monsoon Season 2018 (June to September 2018), inland trainings related to Disaster Preparedness for Effective Response, preparation of Pakistani Team of Rescuers for participation in Disaster Management Field Exercise SRBIJA-18 and formulation of various guidelines.
2. **Aim.** To report performance of NDMA activities during Third Quarter (1st July to 30th September) of the Year 2018.
3. **Disasters / Emergency Situations Handled.** Monsoon Season – 2018.

Key NDMA Activities (1st July to 30th September 2018)

6. **Preparedness**
 - a. **Progress on Decisions of 5th Meeting of NDMC.** The 5th meeting of the NDMC was held under the Chairmanship of the Prime Minister of Pakistan on 28 March 2018 at Prime Minister's Office. In the light of discussions and decisions taken on agenda points presented during the meeting, progress on agenda points is attached at **Annex C.**
 - b. **Disaster Preparedness for Effective Response Trainings.** NDMA in collaboration with ADPC/ NHN commenced training **Nucleus Staff** for subsequent training at district level to offset existing inadequacies in response against disasters. These trainings intend strengthening the coordination mechanism horizontally and vertically within the Govt departments. During the Phase-II of the program, **one training for each Gilgit Baltistan and Balochistan was conducted in September 2018. 2 x Trainings are planned in October and November 2018 in Sindh and Punjab respectively.**

- c. **Revision of National Disaster Response Plan (NDRP)**. National Disaster Management Response Plan was formulated in 2010. Since then, changing environment, technologies, merger of old departments & raising of new departments demanded revision of NDRP-2010. NDMA with the financial assistance from ADPC/ NHN took the initiative of revision of NDRP-2010 to align the Disaster Response Plans with latest disaster situation / environment, experiences and organizational changes in Government Departments. **Outline of the Plan has been finalised, 1st draft of the Plan is expected in October 2018.**
- d. **Preparation of Tsunami Policy Guidelines and Preparedness and Response Plan**. NDMA is in the process of developing National Policy Framework Guidelines on Coastal Earthquake and Tsunami Hazards with the cooperation of UNDP and UNESCO. In this regards, **the 1st draft has been prepared.**
- e. **Activation of NEOC for Monsoon Season – 2018**. In order to ensure uninterrupted monitoring of events/ activities taking place during Monsoon 2018, continuous liaison with relevant stakeholders and rapid rescue and relief operations during any emergency situation, National Emergency Operation Centre (NEOC) at NDMA and Emergency Operation Centres at Provincial levels were activated from 15 June 2018 till 15 September 2018.
- f. **Host Nation Support Guidelines (HNSG)**. NDMA in collaboration with ADPC and Australian High Commission at Islamabad prepared and launched Host Nation Support Guidelines (HNSG) on 21 June 2018 at Islamabad and shared with all stakeholders. Subsequently, **Orientation workshops on Host Nation Support Guidelines were held at following locations for familiarization of Government officials and other stakeholders:-**

- g. **NATO's Disaster Management Field Exercise SRBIJA-18**. NDMA has organised Pakistani Team of 17x Rescuers/ Managers (*pooling from NDMA, CDA USAR Team, Rescue 1122 KP, Rescue 1122 Punjab and*

PAF) lead by Deputy Director (Response-I) NDMA for participation in 18th Exercise “SRBIJA-2018” in October 2018. **NDMA organised/ conducted a scenario based/ refresher training for Pakistani Team in Emergency Services Academy at Lahore from 3 - 7 September 2018.** The Exercise will help Pakistan / NDMA in strengthening response mechanism and further collaboration with NATO/ EADRCC.

- h. **Preparation for Observance of National Resilience Day (8 October) and International Day for Disaster Reduction (13th October)**
- (1) In order to better organise observance/ celebration of National Resilience Day and International Day for Disaster Reduction, a number of coordination meeting were held with various stakeholders/ partners.
 - (2) **NDMA has also encouraged PDMA for observance of these Days by conducting Awareness activities/ Seminars etc at respective Provincial Capitals.**
- i. **Earthquake Simulation Exercise.** NDMA in collaboration with UN-OCHA is planning to conduct a National Level Earthquake Simulation Table Top Exercise at Islamabad from 22 – 23 October 2018. Representatives of Federal & Provincial Govt, UN Organisations and Humanitarian Organisations (NGO/ INGO) will participate in the exercise. **In this regard, various planning meetings were held between NDMA Officials and Planning Team of UNOCHA/ UN ROAP. Finalization of Scenario and conduct modalities of Simulation Exercise discussed during these meeting.**
- j. **Participation in IDEAS Exhibition 2018.** Defence Export Promotion Organisation (DEPO) has invited NDMA to participate in International Defence Exhibition and Seminar (IDEAS) 2018 at Karachi from 27 – 30 November 2018. NDMA will be showcasing a stall at the Pakistan Pavilion to promote core competencies in Rescue and Relief Operations during disaster situation in Pakistan. **In order to better prepare/ participate in IDEAS 2018, a number of IHDs (In-house discussions) and meetings with various stakeholders were held in NDMA in June and September 2018.**
- k. **Issuance of NDMA Relief Items.** NDMA issued following relief items to different stakeholders:-

- (1) 500 x Plastic Mats were issued from I-11 warehouse to the needy persons of Gadoon and Swabi. (Constituency of H.E Senator Sitara Ayaz).
- (2) 1 x 32 KVA Generator was issued to 3 FF Regiment, Turbat from COD Karachi.
- (3) Releasing of 2 x 120 KVA generators to COD Karachi for their operational use was formalized in Aug 2018.
- (4) 1 x 32 KVA Generator was issued to 33 Heavy Regiment Artillery, Gujranwala from H-11 warehouse.

i. **Construction / Maintenance of I-11 NDMA Warehouse**

- (1) Guard Room (14x14 sq ft) was constructed by M/s AKB Enterprises.
- (2) Internally painted/distempered by M/s Muhammad Afzal and Brothers.

m. **Shifting of Stores**

- (1) Shifting of stores from I-11 to H-11 warehouse.
- (2) Shipping containers were relocated at H-11 warehouse.
- (3) 5,000 x tents were shifted from CMT&SD Golra to HRF Sukkur.
- (4) Evacuation from CMT&SD Golra (dismantling of 2 x Flospan and 3 x Rub halls alongwith stores) is in progress.

n. **Disposal of Redundant Stores held with NDMA.** Redundant stock including sleeping bags, miscellaneous mattresses, jerry cans, water filters, water bladders, cutting discs and miscellaneous clothing items were issued to PDMA KP, Sindh, Balochistan, GBDMA, SDMA, CDA USAR, 1122 Lahore and SOS Islamabad.

o. **Enumerator's Training on Multi Sector Initial Rapid Assessment (MIRA) Guidelines**

- (1) After launching of MIRA Guidelines on 31 July 2017, Training of the Trainers (ToT) on MIRA Guidelines was held on 6-8 November 2017 for further training of the nominated officers of District Disaster Management Authorities, Line Departments, INGOs/ NGOs at district level. **2 x days' Enumerators' training was conducted in District Chitral, KP from 27-28 September 2018. 2 x trainings are planned on 30-31 October at Gwadar, Balochistan and 13-14 November 2018 at Nowshera, KP respectively.**

- p. [Guidelines for Cash Transfer Programme in Disasters Management \(CTPiDM\)](#)
- (1) The Guidelines were revised in the light of discussion/ input of Programme Manager, (TDP-ERP Project), Economic Affairs Division (having experience of 14 x cash transfer projects) and shared with all PDMA's to seek their consent/ input.
 - (2) Simultaneously, BISP has also been requested to furnish their views/comments for use of limited services of BISP's Cash Transfer Mechanism (i.e. NSER data only) to avoid additional burden of services charges on Federal/Provincial exchequer as well as issues of reconciliation of huge amounts, data related issues and any future complexities.
- q. [Housing Foundation of Iran \(HFI\)](#). Economic Affairs Division, PDMA Sindh and PDMA Punjab have conveyed their consent for signing of fresh MoU between NDMA and HFI for construction of 17 x Projects (Educational & Health). Further work will be carried out after clearance from **MoFA and Mol**.
- r. [Signing of MoU between King Salman Humanitarian Aid and Relief Centre \(KSHARC\) and NDMA](#). King Salman Humanitarian Aid and Relief Centre (KSHARC) has taken over all the humanitarian and relief tasks/ projects previously carried out by Custodian of Two Holy Mosques Relief Campaign (CTHMRC) during KSHARC's visit to Pakistan in May 2018. **NDMA is planning to sign an MoU with KSHARC after clearance from MoFA.**
7. [Disaster Risk Reduction](#)
- a. [Implementation of Pakistan School Safety Framework \(PSSF\) in ICT](#)
- (1) Pakistan School Safety Framework was developed after a series of National level consultative meetings with Government and private sector stakeholders. It was pretested through a Pilot in 68 public and private schools across Pakistan, AJ& K and GB to view its effectiveness in disaster risk management in the education sector in Pakistan. 263 teachers were trained and 50,000 students benefitted from the programme.
 - (2) Owing to the monumental success of the Pilot, it has been decided to Scale-Up PSSF in ICT as Model Pilot in 500 public, private schools and informal educational institutes, where 1500

teachers will be trained. In this regard, a MoU has been signed for partnership with FDE for the roll-out of Pakistan School Safety Framework (Project) in 391 schools that fall under FDE jurisdiction. The progress is as under:-

- (a) Training for 1st batch of teachers has been conducted for ICT Scale up.
- (b) Training for 2nd batch of teachers for ICT Scale up is in planning phase (training material has been shared with FDE).
- (c) A meeting was held with British Council on 13th September to review the planning for the following upcoming activities:-
 - i. Evaluators Training.
 - ii. Provincial Launches.
 - iii. 2nd Phase of ICT Scale up.
- (d) 2 days training is in planning phase for internal evaluators in ICT.
- (e) ICT Scale up (Phase 02) is in planning phase.

b. **Education in Emergencies**

- (1) Review meeting about the progress of Education Sector Contingency Planning Guidelines (ESCPG) assignment and planning for upcoming National Level Consultative Workshop was held at NDMA on 6 July 2018.
- (2) An Introductory Meeting of Education Sector Contingency Planning Guidelines (ESCPG) and Pakistan School Safety Framework (PSSF) - Provincial Launches was held at NDMA on 20 July 2018.
- (3) First draft of ESCPG guideline was shared by H&H Consultants on 25 August 2018 for review by NDMA and Hope 87.
- (4) A review meeting of the Sector Gap Analysis and ESCPG was held on 11 September 2018.
- (5) The draft documents (Gap Analysis & Education Sector Contingency Planning Guidelines) are being forwarded to International Consultants for vetting.

- c. **Minimum Initial Service Package (MISP)**
- (1) Minimum Initial Service Package (MISP) Task Force meeting was held on 13 July 2018 and task force was notified for contextualization of the MISP Manual in Pakistan.
 - (2) Consultative meetings for Mainstreaming MISP into Contingency Planning were held at Punjab, Sindh, KP and Balochistan in August and September 2018. PDMAs and provincial line departments including P&D, Education, Social Welfare, Health, Women Development, Committee for Maternal & Neonatal, Provincial Commission on the Status of Women and UNFPA participated in meeting.
- d. **Gender Based Violence (GBV) SOPs Validation Workshop.** GBV SOPs validation workshop was held at Karachi on 27 September 2018.
- e. **Asian Ministerial Conference on Disaster Risk Reduction (AMCDRR).** NDMA participated in Asian Ministerial Conference on Disaster Risk Reduction (AMCDRR) that was held from 3 – 6 July 2018 at Ulaanbaatar, Mongolia. A documentary was developed on vulnerable groups in PSSF by NDMA and played for competition held during conference presentation / discussion session on PSSF at Safe School Event organized by the UNICEF Regional Office.
- f. **Bilateral Meetings with UK Academia and DFID.** NDMA participated in Bilateral Meetings held from 27 August 2018 to 2 September 2018 with UK Academia and DFID. The major agenda was to build the capacity and strengthen the existing structures of Government Officials in terms of effective preparedness and response in the entire DRM cycle and to enhance the short and long term potential of NIDM in supporting response for DRR/ DRM through technology transfer and capacity building initiatives.
- g. **Multi Hazard Vulnerability and Risk Assessment (MHVRA) – Chitral**
- (1) NDMA is in process of undertaking MHVRA Study of District Chitral. The project is funded by World Food Program. The activity will cover the following modules:-
 - (a) Assessment of Earthquake, Glacial Lake Outburst Flooding (GLOF), Avalanche, Landslide, Flood and Drought Hazards.

- (b) Exposure / Vulnerability Assessment (Physical, Social & Food Insecurity).
 - (c) Capacity & Risk Assessment.
- (2) NDMA Team undertook field visit from 9 – 19 September 2018 of District Chitral to hold consultation meetings with local authorities, communities & humanitarian organizations, assessment/survey of 28 selected schools as well as visit to vulnerable locations for hazard assessment and collection of data for calculation of exposure and vulnerabilities in the study area.
- (3) NDMA Team also organized a workshop seminar on Multi Hazard Vulnerability and Risk Assessment (MHVRA) and School Hazard Vulnerability and Risk Assessment (SHVRA) on 12 September 2018 in District Chitral. The purpose of the workshop was to brief the audience on MHVRA and SHVRA activities undertaken by NDMA through its Project Management Unit. The workshop also aimed at seeking necessary participation of all relevant stakeholders for smooth execution of MHVRA study in Chitral.
- h. **National Disaster Risk Management Fund (NDRMF) Proposal.**
NDMA has prepared proposal for the conduct of MHVRA in 7 x districts of Balochistan, 8 x districts of KP namely Swat, Nowshera and Shangla. The activity is planned for duration of 18 x months and will cover several impending hazards that the selected districts are exposed to. The hazard selection are based on historical profile of the districts as well as consultation with respective district level stakeholders.
8. **Capacity Building**
- a. **Foreign Trainings / Workshops / Conferences.** NDMA sends officers from PDMA's, USAR Teams alongwith own officers to attend Foreign Trainings / Workshops / Conferences.
 - b. **NIDM Inland - Government Officials Capacity Building Training**
 - (1) 5x Disaster Preparedness and Response Planning (DPRP) Trainings were conducted by NIDM as per following details: -

9. **Audit & Finance**

- a. Internal Audit for the Financial Year 2017-18 was carried out by the Internal Audit team.
- b. External Audit conducted for FY 2017-18 from 3 August 2018 to 3 September 2018 by DG Audit (DM).

10. **Advocacy and Awareness**

- a. **Child-Inclusive Climate Change Adaptation (CCA) Tools**. Child - Inclusive Climate Change Adaptation CCA Tools **are in phase of finalization for printing** that has been developed and designed to strengthen capacity of children within the education sector by mainstreaming climate change adaptation and disaster risk reduction.
- b. **Consultative Media Dialogue**. Consultancy firm has been finalized for National Consultative Media Dialogue on Role of Media in Disaster Management and currently is in planning phase.
- c. **Coffee Table Book**. **Case studies have been compiled and a draft document of a Coffee Table Book to showcase women's leadership and contribution in humanitarian preparedness and response in DRR and DRM through personal stories of resilience were prepared.**
- d. **National Workshops Business Resilience and Role of Private Sector in Preparedness and Response**. Workshop on Business Resilience and Role of Private Sector in Preparedness and Response

for private sector personnel was held on 18 July 2018 in collaboration with ADPC and NHN. The workshop was attended by more than 30 private sector personals. Member Operations, NDMA briefed about the role and responsibilities of NDMA during his address. He also emphasized the importance of leading role of private sector during disasters preparedness and response.

f. **Press Releases, Advertisements & Tickers**

- (1) Important events of NDMA were projected in print media through press release. **6 x Press Releases** were prepared and issued while coverage appeared in **21 x newspaper** covering these press releases.
- (2) NDMA issued **1 x advertisement** during the period.
- (3) **Over 100 x tickers** were aired of different NDMA events on electronic and social media as per requirement.

Conclusion

11. A paradigm shift from “**reactive to proactive**” and “**readiness to being resilient**” approach despite resource constraints (capacity/ financial issues) has helped NDMA / PDMAs and Humanitarian Organisations to deal these hazards / disasters to great extent. Continuity of focus on **Prevention, Mitigation, Preparedness and Capacity Building/ Enhancement** of relevant disaster management bodies is the enduring way to reduce these risks in a confident manner.
