7. **Weather Forecast for Next 24 Hours** Scattered wind-thunderstorm/ rain is expected over the upper catchments of Rivers Indus, Jhelum, Chenab & Ravi along with Khyber Pakhtunkhwa and Rawalpindi, Gujranwala, Sargodha & Lahore Divisions. Last 24 hours significant rainfall recorded is attached as **Annex C**.
8. **Weather Advisory / Press Release**. Met Office has informed on 24 September 2020 that a western disturbance is likely to enter upper parts of the Country from Saturday (26 September 2020, night) and likely to prevail till Wednesday (30 September 2020). Under the influence of this weather system: -
- a. Rain / wind-thunderstorm is expected in Khyber Pakhtunkhwa, Gilgit-Baltistan, Kashmir, Islamabad, Rawalpindi, Attock, Jhelum, Chakwal, Mianwali, Khushab, Sargodha, Hafizabad, Gujrat, Gujranwala, Sialkot, Narowal, Lahore, Sheikhpura, Faisalabad and Kasur during Saturday (night) to Wednesday with occasional gaps.

Dust-thunderstorm are also expected in Bhakkar, Layyah, Dera Ghazi Khan, Multan and Bahawalpur from Sunday to Tuesday.


- b. This weather system will subside the Prevailing hot weather conditions in upper and central parts of the Country.

11. **Warning / Alert.** Keeping in view the higher water level in Mangla Reservoir (1,233.45 feet), Tarbela Dam (1,548.57 feet) and expected rains over the upper catchments of all the Major Rivers which may result in increasing discharge of surplus water from Mangla Dam and Tarbela Dam. All relevant district administrations to sensitize the population residing near the river banks along River Chenab and Jhelum and to take necessary precautionary measures.
